# Territorial Community Grassroots Group Suggestions Territory Citizens Gathering

Sunday, June 27, 2024

- 1<sup>st</sup> Meeting Suggestions -

- 1) speak the truth in a good way
- 2) help community member's most in need, in a non-judgmental way
- 3) encourage Chief and Community Councillor's to be leaders first, and not politicians
- 4) let police do policing
- 5) make consistent and better use of our own Indigenous Restorative Justice Programs
- 6) have the courts adhere to Anishinaabe Law rather than continually impose colonial law
- 7) develop a Non-Political Anishinaabe based Indigenous Territory Justice System
- 8) form a diverse group of Territory Elder Reps to act as the gate keepers of FN community (s)
- 9) provide better support to community "front-line" crisis workers
- 10) add additional key, and important, and crucial support staff
- 11) secure Health Canada Medical Marijuana products to fill the need or want for illicit drugs
- 12) develop land-based addictions eradication programming in each individual FN community
- 13) provide safe houses for the most in need, and not just shelters
- 14) provide affordable housing to the Territory most vulnerable
- 15) impose hefty fines for drug dealers caught selling illicit drugs
- 16) all fines imposed are to be paid immediately, no exceptions
- 17) revoke Band Membership to member's known to be illicit drug dealer's
- 18) assign Community Trespass Notices, and issue immediately to unwanted residents
- 19) secure professionally trained police dogs to sniff out illicit drugs, in vehicles, homes and workplace
- 20) impose community employee drug testing
- 21) start raising revenues for an Anishinaabek Territory Healing Centre
- 22) tighten up citizenship code, add much stricter citizenship clauses
- 23) provide Active, Listening Awareness Protocols that focus on both awareness & prevention
- 24) ensure community member's feel welcomed to attend meetings, and share awareness protocols
- 25) make First Nations inaccessible to unwanted, and unknown individuals
- 26) create and develop secure First Nations "gated" communities
- 27) develop a transparent Territory Nation to Nation Communications Channel
- 28) develop an alternative addiction eradication strategy that works, aimed to help the most in need
- 29) generate Corporate Canada donation revenues streams in support of addiction eradication programs and products, create land-based Healing Programs, stock community food banks, and lend support to Elder's Groups, kids sports, and creative arts
- 30) develop a Territory Grassroots Comprehensive Community Action Plan

#### ADDED DISCUSSION POINTS

- a. Sovereign communities across Canada do not have easy access to Health Canada Medical Marijuana. We need to ensure Sovereign Nations leadership across Canada have routine access to family affordable Health Canada approved Medical Marijuana products, made available in bulk, in as many sovereign communities as possible, to better serve member's dealing with addiction and that will need to replace the need and/or want for fentanyl, cocaine, and a wide array of other illicit drugs the black market dealers are selling the most vulnerable community member.
- b. We also need in every home on sovereign lands, four Naloxone Kits on hand, in each home. Naloxone Kits, 300 Households per sovereign community X 4 naloxone kits per home. The reason for as many as four is the poison the illicit drug dealers are pouring into all communities, not just First Nations, but to all communities, and distributed to the most vulnerable community members, is because the illicit drugs are so strong now, it's not just fentanyl, its stronger, where many gangsters are now distributing "elephant tranquilizer", typically known as "carr-fentanyl", where it takes 3 and sometimes 4 naloxone kits alone to revive one person, an addict and others from an overdose.
- C. How is possible that Health Canada does not allow Health Canada approved Licensed Producers to distribute and sell approved Medical Marijuana, directly to Sovereign First Nations leadership, and or as directed by First Nations leadership, for example, sold directly to their respective First Nations Community Health Departments? How is that now allowed on sovereign lands, governed by the Federal Government?
- d. Why does Health Canada push the added expenses of First Nations paying "retail" prices for Health Canada approved Medical Marijuana products, when First Nations could purchase Health Canada Medical Marijuana products directly from the Health Canada approved Licensed Producer, at a fraction of the cost the Ontario Cannabis Store and Health Canada Cannabis approved Dispensaries sell their retail products for ? It's a shame and not family affordable.
- e. How is it possible that the Veterans of Canada have their Medical Marijuana Benefits paid for from a Federally funded organization (Veterans Affairs), and rightfully so by the way. However, how is it possible the original peoples' of Turtle Island, that have been here since the beginning of time and have had a Treaty signed some 174 years ago with the "Crown", long before Canada was a country and or the province a Province, how is it possible the Anishinaabek peoples' of Canada do not have their Health Canada Medical Marijuana benefits paid for?
